#### 4. Committee reports

- a. **Bethlehem Backyards for Wildlife** Will be receiving 200 native perennial plant plugs on May 16 from a purchase through Kind Earth Growers in Ottsville, and we will be planting them in the ten beds up on the Hoover Mason Trestle. Very excited that this will bring more colorful blooms through the Spring, Summer and Fall. Also, we now have two water sources up on the Hoover Mason Trestle (HMT) so that we don't have to haul water containers up there. The irrigation system has been fine-tuned and is on a timed schedule to keep everything hydrated between rains, but these two spigots give us more flexibility and will be most helpful when we plant the 200 new flowering native perennials.

# 5. External committee reports

- a. Monocacy Creek Watershed Association
  - We continue the work along the Gertrude Fox Conservation Area trail that will be about a 1/2-mile loop that starts across from the Oasis Community Center near Center Street and Route 22 and goes east along the creek side

and through a wooded area, looping back to its starting point. We have been clearing invasive species and branches, and the trail is now definitely easy to follow as it meanders along the creek bank. Platform steps and benches will also be included in this project—hoping for a late-Fall of 2022 completion.

- We are also meeting with the City of Bethlehem engineering department to choose floodplain and stream bank restoration projects that might be done as a part of the Fish & Boat Commission proposals we recently received.
- We had a hugely successful Monocacy Creek Cleanup event on Saturday, April 30! 57 volunteers picked up lots of trash, storm debris and litter, and that's record number of volunteers. Police Chief Michelle Kott, ten police Academy cadets, Morning Star Rotary members, Trout Unlimited members and many people from across the Lehigh Valley turned out and covered the long stretch from Illick's Mill all the way down to Union Boulevard. Special thanks to Katie Trembler and her two daughters for pitching in!
